 1st List: Officers arranged according to rank; nurses, if any; civil employees, if any. These names should be numbered consecutively beginning with No. 2d List: Non-commissioned officers above Grade 17, (Paragraph 9, Army Regulations), arranged according to grade.
 3d List: Enlisted men below Grade 16, (Paragraph 9, Army Regulations), arranged according to the usual formation of the Company, that is, by squads. The names should be numbered consecutively beginning with No. 1.
