

INSTRUCTIONS FOR FILLING OUT THIS FORM

Separate lists of FIVE COPIES EACH will be filled out by each company or detachment commander as follows:  
 1st List: Officers arranged according to rank; nurses, if any; civilian employees, if any. These names should be numbered consecutively beginning with No. 1.  
 2d List: Non-commissioned officers above Grade 17, (Paragraph 2, Army Regulations), arranged according to grade.  
 3d List: Enlisted men below Grade 16, (Paragraph 3, Army Regulations), arranged according to the usual formation of the Company that is, by squads. These names should be numbered consecutively beginning with No. 1.
