INSTRUCTIONS

Separate lists of TWELVE COPIES EACH will be accomplished by each romplany or detachment commander as follows:

1st Class: Officers arranged according to Rank, Nurses, Army Field Clerks, Field Clerks, O. M. C., Civilian Employees. Names to be numbered consecutively beginning with No. 1.

2ad Class: Non-commissioned Officers down to and including Color Sergeant (See A. R. Par. 9).

3rd Class: All enlisted men below Color Sergeant (A. R., Par. 9), arranged according to usual formation of the Company, that is, BY SQUADS.
