## INSTRUCTIONS FOR FILLING OUT THIS FORM

- All U. S. Military Personnel, including civilian employees of the Army, returning to the United States, will be listed on this form, which will be accomplished in twelve copies by Personnel Adjutant of Port of Embarkation.
- The passengers will be classified and grouped under the following headings, with reference to the reason for their return: (1) "Sick and Wounded," (2) "Prisoners," (3) "On Leave," (4) "For Discharge," (5) "For Duty," (6) "For Retirement," (7) "For Orders," (8) "Deceased."
- Each group will be arranged according to rank and grade (see A. N., Par. 9). Army Field Clerks and Field Clerks Q. M. C. to be inserted between officers and enlisted men.
- The names will be numbered consecutively within each group, beginning with No. 1.
