3rd Class: All calisted men below Color Sergeant (A. R., Par. 9), arranged according to usual formation of the Company, that is, BY SQUADS.

This form, when used to list CASUAL military passengers will be accomplished in like manner, but within each class all casuals will be sub-grouped under the following headings with reference to the reason for their return, not more than one such sub-group being listed on the same sheet: (1) Deceased, (2) Sick and Wounded (9) Prisoners, (4) Fer Duty, (5) On Leave or Furlough, (6) Miscellaneous.
