1. There have been 24 descendants of Company L soldiers identified (not all have registered). They represent the following soldiers. But every registration actually represents many more descendants. For example, there are currently 62 known descendants of Private Harry Shankman. While the number of descendants who have registered may seem like a small number, they represent a much larger number. If each soldier had 50 descendants there would be at least 1,200 descendants who have the opportunity to know details of their ancestor's WWI valor. Please share our website with your relatives. #### AMERIAN, Oscar **Great Grandfather**

AMERLAN, Oscar, Private. Enlisted 16 August 1917. Bugler. Took part in the attack on Hamel, Chipilly Ridge and Gressaire Wood, Meuse-Argonne battle, and St. Mihiel front. Was wounded and received the Purple Heart

#### ARDAGH, John C Grandfather

Private First Class. Enlisted 20 August 1917. Name changed from John to Joe 21 February 1918. Was hospitalized and on release was assigned to American Camps, Winchester Area, Winchester, England.

#### **BISSELL**, Charles Grandson

Private First Class. Enlisted 28 June 1917, Illinois National Guard. Reported for WWI duty with Company L on 25 July 1917. Transferred on 2 February to HQ Company A, 108th Military Police.

#### COLBY, George Uncle

Sergeant. Served with Illinois National Guard. Reported for

WWI duty 25 July 1917 and medically discharged 23 January 1918.

#### FOSTER, Wesley Great-uncle

Sergeant. Regular Army. Prior service. Killed in Action October 11th, 1918 during the Battle of Bois de Fays. Awarded the Silver Star medal for gallantry during combat.

#### HALVERSON, Harold Relative

Sergeant. ILNG then 132nd. Company L Roster December 1918 A.E.F. Junglinster, Luxembourg: Listed as Sergeant. Company L Morning Report January 1918: Transferred to Company L January1918. Transferred to Company K, 132nd Infantry.

#### **HEALY**, Paul.

Sergeant. Enlisted November 1917. Received the Silver Star medal for gallantry during combat.

#### **KEATING**, Arthur Grandfather

First Lieutenant. Enlisted 14 May 1917. Listed as Private First Class- Company L Muster Roll Nov-Dec 1917 Camp Logan, Houston Tx: Transferred to Headquarter Company 132nd INF per RSO#118 dtd 20 Dec 1917. Returned to US April 1919 as 1st Lt, Company C, 305th Infantry, 77th Division.

#### **KOZIELSKI**, Joseph V Great Uncle

Immigrated from Poland in 1913. Enlisted 5 September 1917. Died of gunshot wounds received in action at Verdun, October 10, 1918. October 11, 1918, Reinterred at MeuseArgonne American Cemetery. Company L Muster Roll Nov-Dec 1917 Camp Logan, Houston Tx: Enlisted 5 Sep 1917. Listed as Private. Transferred from 108th Supply Train to 33rd DIV 8 Dec 1917 and Joined Company L on 8 Dec 1917.

## KURATKO, Rudolph J Grandfather

Corporal. Assigned Company L November 1917 from Headquarter Company 333rd Infantry.

#### LeBEAU, Walter E. Grandfather

Private. Enlisted May 1918. Assigned Company L April and dropped from roll July 1918 due to combat wounds. 1919 was assigned to Headquarters Company, 132<sup>nd</sup> Infantry.

#### MARES, Frank C Grandfather

Private First Class. Third Platoon. Enlisted 1917 ILNG, served with Company L until war over. PFC Frank C. Mares was rated as a sniper. He suffered from respiratory issues due to being gassed. It was believed that his being gassed contributed to his death in 1958. When he returned from the war he married. They had two children. He never talked about his time in service; and no relatives ever asked him. He kept a wartime journal that documented the travels of Company L throughout their European service. #### MILLER, Earl Father

Enlisted 19 Sep 1917. Listed as Private. Transferred to 132nd INF 20 Apr 1918. Assigned to Co L, 23 Apr 1918. August 1918 Sick-in-Hospital. - Company Roster November 1918 A.E.F.: Listed as Private. Rejoined Nov. 4th 1918. Note: This supports comment by his granddaughter that he was wounded in action.

#### **NESBITT**, Robert E. Grandfather

Private. Enlisted 27 Feb 1918. Listed as Private. Transferred to 132nd INF per SO#108 Hdq 33rd DIV dtd 20 Apr 1918. Assigned to Co L, 132nd INF. Wounded 13 October 1918; in Hospital.

#### PALLIN, Gustaf Carl Grand Father

PALLIN, Gustav. Private. Enlisted April 1917 and Joined Company L in December 1917 from the 108th Supply Train.

#### PIERCE, Robert Grandfather

Private. Enlisted 22 Feb 1918. Transferred to 132nd INF Apr 1918. Assigned to Co L, 132nd INF April 23, 1918.

#### **PLAMONDON**, Ambrose Grandfather

Enlisted, under-age on 9 Aug 1917. Listed as Private. Transferred from Supply Company 132nd INF on 24 Apr 1918. Transferred to Base Hospital, Camp Logan, 28 May 1918, dropped from Company L. Assigned in France to Company M, 7th Infantry.

#### REUTER, Lee W Father & Grandfather

Corporal. Prior service Company L, Illinois National Guard. Company Clerk and founding member of the original Men of L postwar organization.

### RIPLEY, Luther Great Grandfather

Private. Enlisted 26 May 1917. Assigned to Company L 2 October 1918. Descendants provided information that Private Ripley was assigned as a runner (carrying messages), and was gassed during battles at Verdun and in the Meuse-Argonne. A monument with his name and nine other soldiers was erected in France.

### SCHWARTZ, Arnold Father

Private . Enlisted 23 April 1917. Company L November, 1917. Transferred to Headquarters Company 132nd INF Feb 1918. No record of service overseas.

SHANKMAN, Harry Grandfather (3) & Great Grandfather (3) Private First Class. Fourth Platoon. Drafted. He suffered

respiratory issues due to being gassed and died at age 55 as a result. Arrived U.S. in 1910 and naturalized 1919.

#### SIWEK, Jacob Father

Private. Enlisted Aug 1917; transferred from the 108th Supply Train and assigned Co L 8 December 1917. Sick in Hospital August 1918; returned to U.S.

#### Van LERBERGHE, Camiel. Great Grandfather

Private. Enlisted 23 February 1918; Assigned Company L on 23 April 1918. Second Platoon. Gassed in battle.

#### YOUNG, Samuel T Great Uncle

Private. Drafted. Fourth Platoon. Arrived France August 1918 and Joined Company L October 1918.

Our outreach efforts have included adding our organization's information to the Veteran's Legacy Memorial (VLM): <a href="https://www.vlm.cem.va.gov/">https://www.vlm.cem.va.gov/</a> and <a href="https://www.vlm.cem.va.gov/">Find-A-Grave</a>. We have contacted many American Legion and Veteran of Foreign War posts. While most of Company L soldiers were from the Chicago area, many were from many other states. Where location information is available, we contacted local history and civic organizations. Descendants have indicated they discovered our website from Find-A-Grave (5), Internet searches (8), Ancestry (2), Grave Marker (1), Obituary page (1), County History Facebook page (1), and relatives (6).



4. Soldier's Story: This issue highlights Sgt. James Reynolds of Company L's 2<sup>nd</sup> platoon who had the special mission assigned to him of mopping up enemy positions. He ran into three machine guns which were still in operation. He captured the crews and brought them in as prisoners. He cleaned out 3 machine gun nests Battle of Bois de Fays. He captured the crews and brought them in as prisoners. He was cited for gallantry in action by General Pershing and General Bell and was eligible for the Silver Star Medal. The Silver Star Medal is the United States' third

highest award exclusively for combat valor. The Silver Star was not established as an individual medal until July 19, 1932. At that time, veterans of World War I who had been cited for "gallantry in action" and awarded the "Citation Star" were, based upon specific criteria, authorized to request issuance of the Silver Star Medal in lieu of the earlier ribbon device.
